All reception breaks and the Welcome Reception on Monday 30th September will be taken amongst the exhibition stands providing high exposure to the delegates for all exhibitors.

Market and Exhibition Packages

A standard space provides a table and chairs which plenty of space to exhibit and demonstrate your products and services.

Pricing

- 2m x 2m - Small not for profit (less than £500,000 income) £450 plus VAT at 20% = £500 for table and 2 chairs and one attendee.
- 2m x 2m - Larger not for profit (more than £500,000 income) £600 plus VAT at 20% = £720 for table and 2 chairs and one attendee.
- 3m x 3m - Not for Profit Organisation £850 plus VAT at 20% = £1020 for table and 2 chairs and two attendees
- 3m by 3m - Commercial Organisation £1000 plus VAT at 20% = £1200 for table and 2 chairs and two attendees

Entitlements:

- 3 days exposure
- 2m x 2m or 3m x 3m exhibition space
- Table and two chairs
- Catering throughout the day for one or two representatives on each full exhibition day
- Logo and organisational name on conference website
- 1 or 2 x invitations to the Conference Welcome Reception: Monday 30th September

Additional exhibitor passes for organisation representatives who wish to have entry to the exhibition hall may be purchased for £200 plus VAT = £240. Booking forms for additional passes and tickets to the social functions will be available in the exhibition kits forwarded on receipt of the signed contract and full payment.



Terms and Conditions
